Any illegal activity, possession, /use of drugs, alcohol, or weapons, sexual activity, or relentless disrespect for authority will be cause for immediate dismissal. In this case, it is the responsibility of Guardians to provide a way home for Participants. Participation in future opportunities provided by the GSYM will be discussed with Guardians, Youth, and Youth staff as soon as possible after returning from the Youth event.
